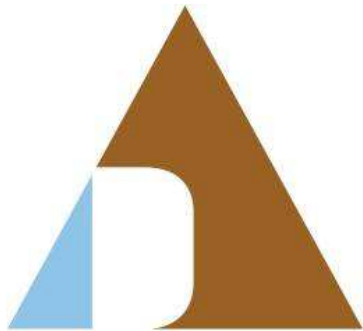

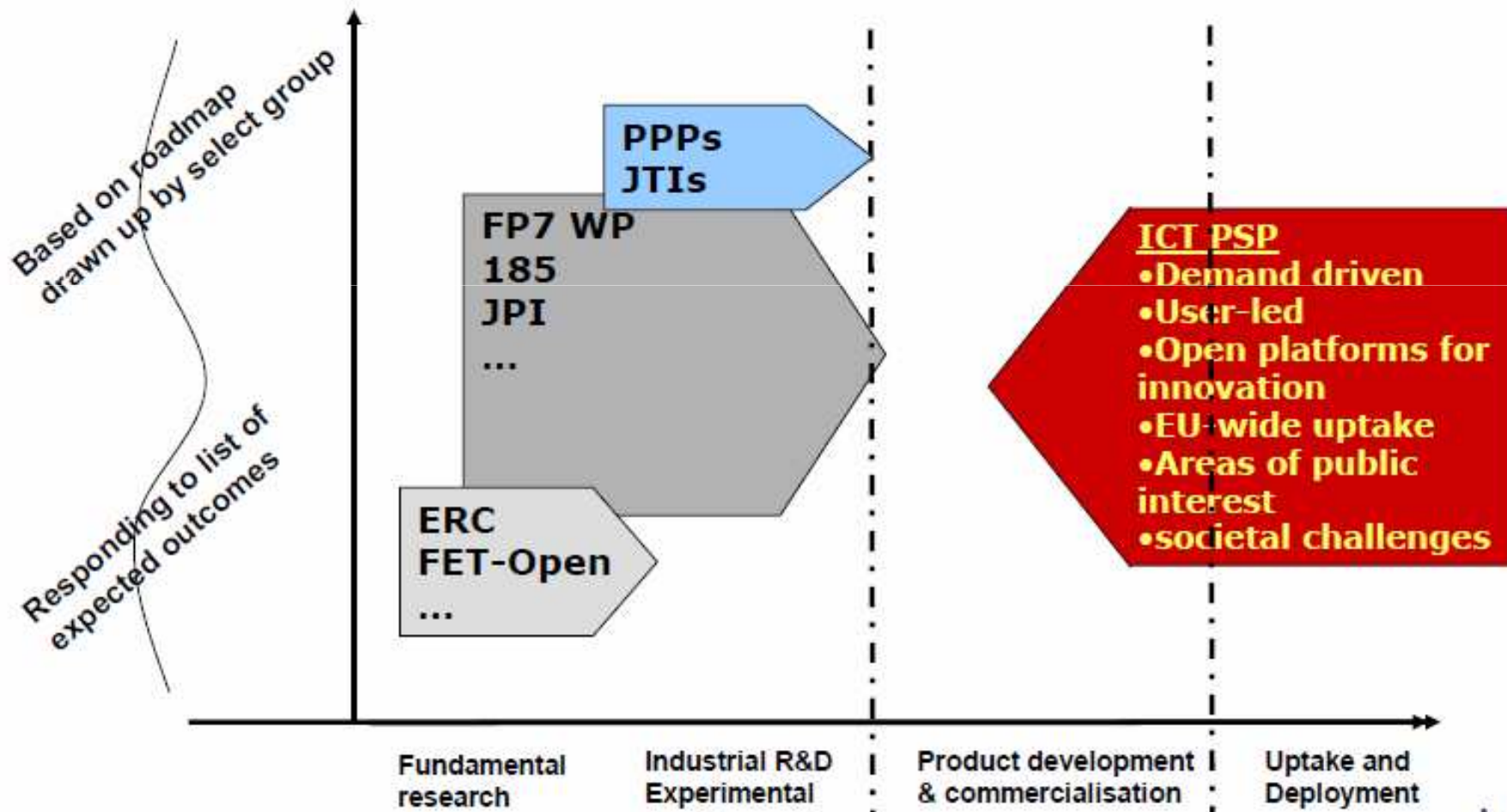

Tipos de proyectos (ICT PSP)

- Pilot and testing in real settings
 - Putting users in the lead, demand driven innovation
 - Significant coverage and size
 - Supporting policy priorities
- Diffuse widely the results
 - Ensure “replicability” and scalability
- Build on Member States initiatives
 - Share experience
 - Help develop common approaches
 - Ensure interoperability
- Prepare for wider actions
 - Consensus and partnership building is essential for interoperability and EU-wide deployment

Resumiendo...

Tres instrumentos complementarios:

*Apoyo a soluciones TIC a **nivel Europeo** → **Pilotos Tipo A***

- Pilotos a gran escala focalizados en la **Interoperabilidad**
- Actores clave: **Estados Miembros** son los líderes pero la **Industria** tiene un papel clave en la implementación del piloto.
- Dimensión política fuerte

*Estimular el **uso innovador de las TIC** en los sectores públicos y privados → **Pilotos Tipo B***

- Implementación de **servicios innovadores basados en las TIC** mediante pilotos
- Actores clave: **la cadena de valor completa** (proveedores, usuarios, autoridades públicas)

Movilización/Intercambios** entre profesionales y constructores de políticas → **Redes Temáticas

- Desarrollo de **nuevos esquemas para la implantación de las políticas** a través del intercambio de experiencias y mejores prácticas.

One “transitory” instrument, reserved for “digital library” theme:

*Combining consensus building / awareness raising / large scale implementation → **BPN**
(Best Practice Network)*

Resumiendo...

Main features of Pilots Type A

- Focus on **interoperability** and building on Member States solutions
- Member States - Lead actors (Industry key role in the Implementation)
- The outcome should be an **open, common interoperable solution** with results widely disseminated and available to all Member States (→ 1 project per objective)

Scale and participants

- Legal minimum of **6 Member States** (=national administrations or competence centres acting on their behalf) or associated countries participating in the consortium.

Duration and Funding

- Duration is typically up to **36 months** with a pilot service operating for 12 months.
- The EU contribution is limited to the **costs for achieving interoperability**. The indicative Community contribution available is **5-10M€ / pilot**

Resumiendo...

Main features of Pilots Type B

- Carry out an **implementation** of an ICT based innovative service under realistic conditions. Replication and wide validation of best practices can be specified in objective.
- emphasis on **fostering innovation** in services → e.g. take-up completed R&D work, extend already tested prototype services or combine / integrate several partial solutions to realise a new innovative approach

Scale and participants

- Minimum of **4 legal entities** from 4 different Member States or associated countries.
- Consortia are expected to engage the **complete service value chain**, including relevant public authorities (sustaining partners), service providers, industrial stakeholders & users

Duration and funding

- Duration is typically **24-36 months** including the operation of a pilot service
- The Community contribution is typically in the range **2-3 M€ / pilot**

Resumiendo...

Main features of Thematic Networks

- bring together stakeholders - **explore new ways of implementing ICT based solutions.**
- E.g. **working groups, workshops, exchanges of good practices** in view of **action plans, standards and specifications**
- **Clearly defined and measurable** results - shall be in the public domain.

Scale and participants

Minimum **7 legal entities from 7 different Member States or associated countries.**

Duration and funding

- Duration between **18-36 months.**
- EC contribution is **300-500 K€/network** funded through **lump sums**

Resumiendo...

Main features of Best Practice Network (BPN)

- Only for the **digital libraries** theme, only for a transition period up to 2011.
- Promote the adoption of respective standards and specifications by **combining** the "**consensus building and awareness raising**" function of a network with **large-scale implementation** on a **sufficient mass of content**.
- The commission can organise "Clustering meetings" in order to **achieve broad consensus and create the conditions for the widest possible uptake** of the recommendations of the BPNs.

Scale and participants

- Legal minimum of **7 legal entities** from 7 different Member States or associated countries.

Duration and funding

- The indicative Community contribution available is **3 - 5 M€** per BPN

Factores Clave para el Éxito de las Propuestas

- Énfasis en el despliegue
 - Explotar resultados de investigación ya existentes.
- Servicios orientados a reducir la carga administrativa (burocracia)
 - Tanto para ciudadanos como para empresas
- Servicios orientados a impulsar la participación ciudadana
- Interoperabilidad.... pero que favorezca la innovación
- CIP/ICTPSP es el instrumento de apoyo principal
 - Pilotos y redes temáticas.



¿Quién puede participar en ICTPSP?

- Abierto a entidades legales de los Estados Miembros de la UE.
- Pueden participar terceros países.
 - En igualdad de condiciones si existen convenios.
 - Otro países pueden participar, pero sin obtener financiación.

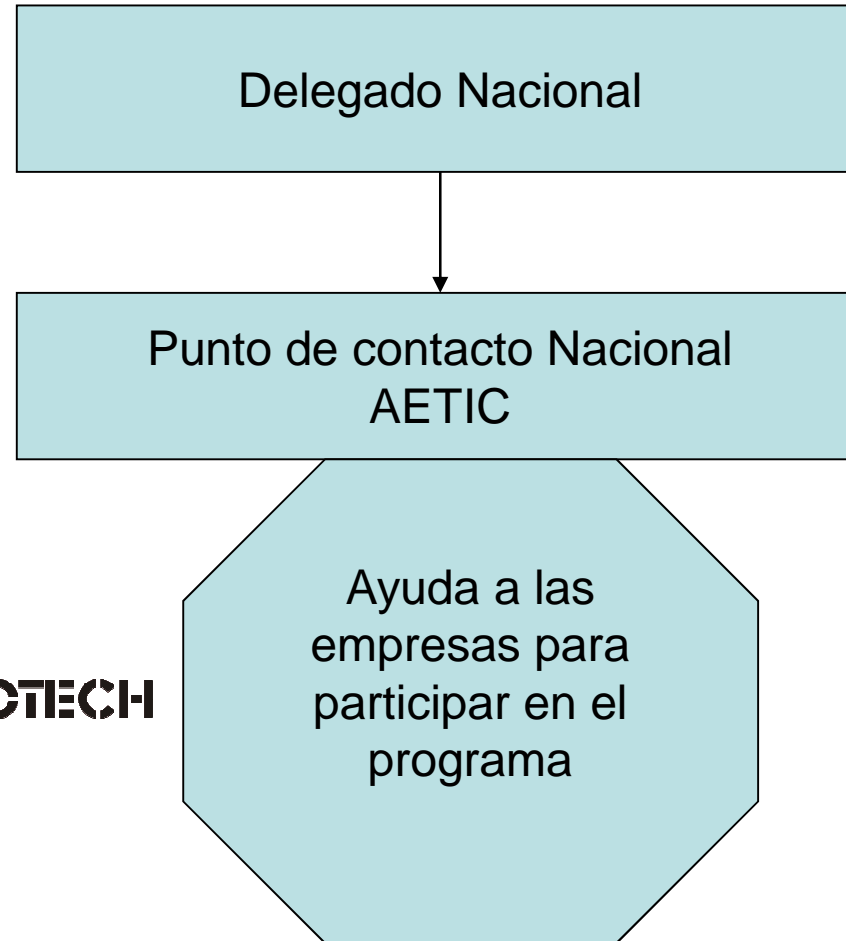

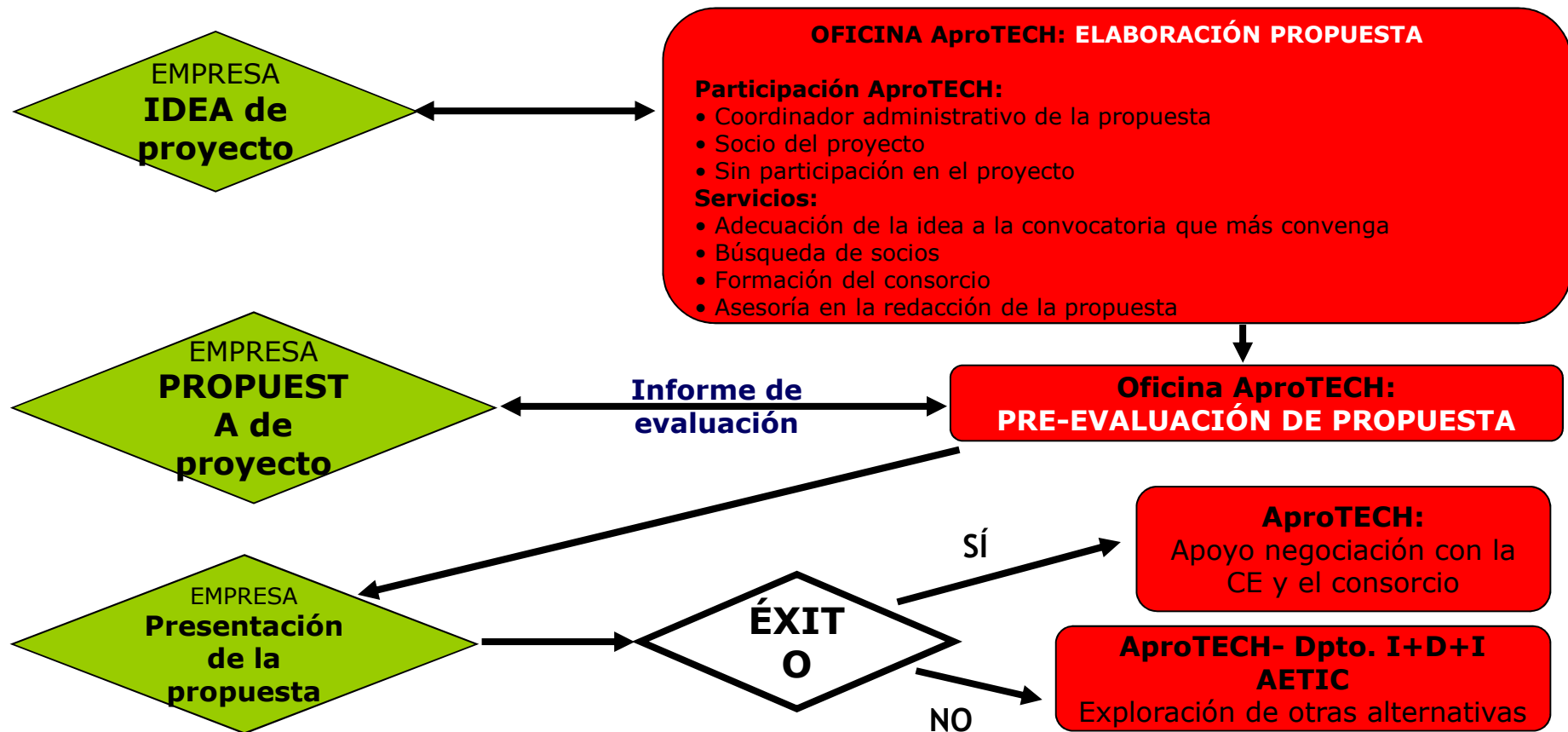

Eligibility of proposals

Proposals must involve a certain minimum number of mutually-independent legal entities of the required type from different EU Member States or ICT PSP Associated countries (Croatia, Iceland, Liechtenstein, Norway, Serbia, Turkey)

Pilot A = 6 partners

Pilot B = 4 partners

Thematic Network = 7 partners

Best Practice Network = 7 partners

Eligibility of proposals

- Provided there is the minimum number of EU/ICT PSP Associated country partners, organisations from elsewhere can also participate in a project (with Commission agreement) but without funding
- Note that *Israel* and *Switzerland* have signed association agreements with FP7 but not with ICT-PSP

Eligibility of proposals

Proposals must be submitted before the call deadline - **1st June 17h00** - using the Commission's electronic proposal submission system (EPSS)

Non-eligible proposals are not evaluated !

Electronic Submission

- Proposal coordinator registers with the EPSS on our call page and obtains ids and passwords for himself and his partners
- The consortium prepares the proposal, then submits it before the deadline
- Submission failure rate = $\pm 1\%$

Only reason; waiting till the last minute

Technical problems

Panic-induced errors

Too late starting upload, run out of time

- Summary
- Relevance (bullet points = sections)
- Impact (idem)
- Implementation (idem)

Evaluation criteria

Evaluation by independent experts on:

- Relevance
- Impact
- Implementation

Each criterion is more fully explained by descriptive bullet points

Criterion threshold	3/5
Overall threshold	-

Evaluation procedure

- Individual reading by three or more experts
- Experts meet in “Consensus group”
- All experts in objective in Panel meeting
- Evaluation Summary Report (ESR)
- Commission selection of proposals for negotiation

(based on Overall score respecting the budget and/or numbers limitations described in the Workprogramme)

Basic principles

- Remember the three evaluation criteria have fuller descriptive bullet points
- Familiarise yourself with the bullet points; write them into your proposal
- The evaluators are looking for them; they are what they are going to score your proposal on

Pre-proposal check

Use the pre-proposal check service* to make sure your proposal is eligible and in scope for this call.....

.....And do it before you prepare your proposal, not afterwards

*described in the Guide for applicants

ICT Helpdesk

Use the ICT PSP Helpdesk* to check any financial or legal elements you are uncertain about.....

.....And do it before you prepare your proposal, not afterwards

*address in the Guide for applicants

Writing the proposal

Divide your effort over the evaluation criteria!

- Many proposers concentrate on the technology, and lose marks on the project planning (implementation) or impact description

Writing the proposal

Think of the finishing touches which signal quality work:

- clear language
- well-organised contents, following the Part B structure
- useful and understandable diagrams
- no typos, no inconsistencies, no obvious paste-ins, no numbers which don't add up, no visible annotations or screwed-up diagrams, no missing pages ...

Writing the proposal

Make it *easy* for the evaluators to give you high marks. Don't make it hard for them!

- Make sure you submit the latest, complete version of your proposal
- Don't write too little; cover what is requested
- Don't write too much
- Don't leave them to figure out why it's good, tell them why it's good
- Leave nothing to the imagination

Writing the proposal

Make sure your Project Workplan reflects the promises you made in the rest of your proposal. For example:

- Good project management implies clear Workpackage leadership
- Strong Impact implies an important dissemination effort
