

SPORTS SCIENCE FACULTY CONTINGENCY PLAN FOR THE PREVENTION OF CORONAVIRUS INFECTION

Following the instructions of the COVID-19 Monitoring Committee of the University of Murcia, the following measures are adopted, the temporal scope of which will be marked by the rector's resolutions which, in turn, will be determined by the regional and state guidelines.

This Dean's Office of the Faculty of Sports Sciences establishes the following contingency measures for teaching activity.

1. The theoretical and practical classes of the Bachelor and Master degrees are transferred to virtual classes to continue with non-attendance teaching. Depending on the characteristics of each subject and the possibilities of each teacher or team of teachers of the subject, one or more of the following options should be chosen:

a) Students will be provided with the necessary documentation for the acquisition of the transversal competences and the subject matter marked in the Guía Docente (Teaching Guide) of each subject through the section Resources of the Aula Virtual. This documentation may include, among other resources, class presentations, specific extracts from the basic or complementary bibliography, articles or publications, texts on web pages, etc. Remember that the library will not be accessible, so try to provide all documentation in .pdf format or in links to operational web pages.

b) Recorded (non-real-time) video-conference teaching. The professor may film himself with the software available at UMU or any other tool, master sessions that are supported by any multimedia material. These videos will be uploaded to a server (UMU's own or external) and will be shared through the Virtual Classroom Resources section with the students of the subject.

2. These telematic teaching actions must be undertaken and applied progressively, following the current academic calendar and the schedule set out in the Guía Docente (Teaching Guide), until the time indicated by the competent authorities.

3. The teaching staff must use all the telematic resources that the Aula Virtual allows (tarefas, foros, chats, own web page, etc.) to: i) guarantee the continuity of teaching, ii) obtain the necessary evidence on the achievement of the objectives and the competences marked by the students, as well as iii) objectively discern and justify their qualification in the evaluation systems that are used. 4. When the time comes (to be determined), each subject coordinator, after agreeing on his or her proposal with the Academic Committee for the Degree, will establish the necessary modifications to the evaluation systems and criteria included in the current Teaching Guide in order to be able to qualify the subjects according to the very conditions of this period of non-attendance teaching, the contents finally taught, and the competences that have had to be achieved during the whole four-month period.

5. Practicum I and Practicum II: All the curricular and extracurricular practices of the UMU students are suspended. Also, all practices of organizations, companies and institutions that are carried out in our University. However, as long as the training centre ensures the possibility of carrying out the activities The training will be carried out in a non-attendance way, so that it will be possible to continue with the practice. From this moment, a period of work and telematic tutoring is opened for to properly prepare the Report of Practice, according to the instructions marked by the Teacher's Guide and the Training Project. The writing of this report will be conditioned, Obviously, because of the partial achievement of the objectives of the subject, taking into account the schedule developed and collected in the training diary to date. Both the academic and professional tutors will take these events into account when evaluating the work. Communication channels will be established, appropriate in each case, with the professional tutor and the usual virtual tutoring with the academic tutor will be maintained, in order to complete the document and be able to evaluate it according to the dates and format originally foreseen in the Teaching Guide.

6. TFG/TFM: since data collection and face-to-face tutoring are ruled out, each student, in telematic contact with their tutor, will make the relevant adjustments to the objectives and methodology of the work when necessary. The usual virtual tutorials will be maintained in order to complete the document and be able to evaluate it according to the dates and format originally foreseen in the Teaching Guide.

7. The **official calls for TFG and TFM examinations and defences are maintained**, from moment, on the scheduled dates.

8. For **mobility students** (Erasmus, Sicue. Etc.) a follow-up will be carried out of the Mobility Coordinators by the virtual environment that they consider most appropriate.

9. In relation to the **complementary activities of teaching in person**:

a) The activities that were planned for the coming weeks will be rescheduled; specifically, talks, conferences, seminars that required the displacement of people by public transport or from other locations.

b) Scheduled talks in high schools and secondary schools are cancelled or delayed.
The Vice-rectorate of Studies has announced that it is studying possible changes to the calendar the academic period of the second term, to the call for exams and the TF defense.

The Vice-rectorate of Studies has announced that it is studying possible changes in the academic calendar that would affect the second term, the call for exams and the defence of TF (Final Work).

FACILITIES: The Rector of the University of Murcia has signed an obligatory resolution, the third point of which indicates:

Notwithstanding the provisions of the previous point, and without prejudice to the general recommendation of the health authorities to restrict mobility, such as the declaration of the State of Alarm allows "travel to the workplace to carry out (the) work, professional or business service", members of the university community (WORKERS) may access voluntarily to the buildings, using their university cards, to perform essential tasks related to teaching, research, management or administration.

At no time should students or family members have access to university facilities. It is reiterated that only workers can access the university to carry out an essential task.

This plan is subject to change in line with developments.
